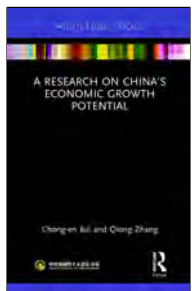

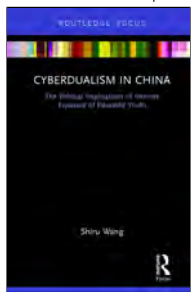

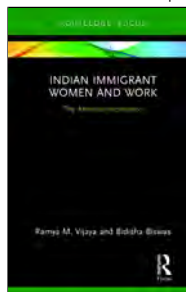

The authors use historical records, previously unpublished gender disaggregate immigration data,
